Contested Matters in non-Ch. 13 bankruptcy cases include: Main Case Motions¹; Non-Ch. 13 fee applications (including final report and fee applications and other Chapter 7 Trustee motions or applications); status conferences on objections to claims and objections to exemptions in any non-Ch. 13 bankruptcy cases.

For purposes of Judge Blumenstiel's calendar, Contested Matters

will not include: Motions filed in cases under any chapter of the Bankruptcy Code for relief from the Automatic Stay, to extend the Automatic Stay, or to seek a determination as to whether the Automatic Stay applies; or any motion not pertaining to the Automatic Stay filed in a case pending under Ch. 13 of the Bankruptcy Code.

Motions pertaining to the Automatic Stay will be heard on the dates referenced in Part B, below. Motions in San Francisco Ch. 13 bankruptcy cases will be heard on the dates referenced in Part C, below. Motions in Salinas Ch. 13 bankruptcy cases will be heard on the dates referenced in Part D, below.
