- The Alameda County Bar Association's Volunteer Legal Services Corporation (VLSC) provides free direct legal assistance to self-represented persons who need assistance with their bankruptcy case in the Oakland Division of the United States Bankruptcy Court for the Northern District of California.

The Program is designed to assist debtors who do not have a bankruptcy attorney. The VLSC provides free direct legal advice and, in some instances, representation. VLSC cannot represent all such debtors due to income guidelines and other limitations. Appointments are mandatory. - The Contra Costa County Bar Association (CCCBA) offers a Bankruptcy Workshop presented by attorney members of the CCCBA Bankruptcy Section. The attorneys present cannot represent you. Information that you provide the attorney present will be held strictly confidential. The attorney will not consult with you outside this program and will not become your attorney regarding any specific matter you may discuss with the attorney. Nothing that is said or done during this program creates an attorney-client relationship.
