Circuit's repeal of the *Entz-White* decision in the fall of 2016, new frontiers have opened up in the battle over the enforceability of default interest, late fees, and similar provisions in pre-petition loan agreements. Are these provisions enforceable under California's liquidated damages statute? Does Bankruptcy Code section 506(b) require the lender to prove the reasonableness and compensatory nature of the default rate?
