Reassignment of Cases Pending in the Oakland
Division and the Santa Rosa Division

Misc. Pro. No.: 23-401

This order sets forth the reassignment of cases in the Oakland Division and the Santa Rosa Division of this Court¹, effective February 1, 2023.

Accordingly it is ordered that:

1. With the exception of the cases listed in paragraphs 2 and 3 of this *Order*, all Oakland Division bankruptcy cases pending as of February 1, 2023 and assigned to Judge Roger L. Efremsky shall be reassigned to the following judges of this Court based on the last digit of the case number:

Judge Charles Novack: 0, 2, 4, 6 and 8 as stated on the attached **Exhibit A**.

Judge William J. Lafferty: 1, 3, 5, 7, and 9 as stated on the attached **Exhibit B**.

Any associated adversary proceedings are reassigned to the judge responsible for the main case.

2. *In re North Fork Community Power, LLC*, Case Number 22-41001, and any adversary proceeding associated with Case Number 22-41001, shall remain assigned to Judge Roger L. Efremsky.

3. *In re Pacific Steel Casting Company LLC*, Case Number 19-40193, and *Little v. Speyside Fund, LLC, et al.*, Adversary Proceeding Number 19-4057, shall be reassigned to Judge Charles Novack. (See attached **Exhibit A**).

4. With the exception of cases listed in paragraph 5 of this *Order*, all Santa Rosa Division bankruptcy cases, and any adversary proceeding associated with such a bankruptcy case, pending

1 as of February 1, 2023 and assigned to Judge Roger L. Efremsky shall be reassigned to Judge
2 William J. Lafferty. (See attached **Exhibit C.**)

3 **5.** *In re Debbie Reid O'Gorman*, Case Number 21-10374, and any adversary proceeding
4 associated with Case Number 21-10374, shall remain assigned to Judge Roger L. Efremsky.

5 **6.** Notwithstanding transfer of a case to the reassigned judge, hearings may be held
6 remotely, or in the division of the assigned judge or otherwise as the needs of the parties and the
7 Court dictate. Court hearing and calendaring information is available from the Court website at


