15 **ORDER CONFIRMING PLAN OF REORGANIZATION UNDER CHAPTER 11**  
16 **(SUBCHAPTER V)**

23 court **ORDERS** as follows:

24 **1.** The Plan is hereby **CONFIRMED**, pursuant to 11 U.S.C. §  
25 1191(b).

26 **2.** Plan payments shall be made as provided by § 8.04 of  
27 the Plan.

28 **3.** As provided by § 8.02 of the Plan, the Effective Date  
of the Plan shall be \_\_\_\_\_.

1       **4.**   Consistent with 11 U.S.C. § 1192, Debtor is not  
2 entitled to a discharge until Debtor has completed all payments  
3 due within the Plan's term. If and when issued, such discharge  
4 shall apply to all debts described in 11 U.S.C. § 1141(d)(1)(A),  
5 except those described in 11 U.S.C. §§ 1192(1) and (2) and  
6 1141(d)(2).

7       **5.**   As required by 11 U.S.C. § 1183(c)(2), no later than 14  
8 days after substantial consummation of the Plan, Debtor shall  
9 file a notice of substantial consummation and shall serve such  
10 notice on the Subchapter V Trustee, the United States Trustee,  
11 and all creditors and other parties in interest. Debtor shall  
12 promptly file a certificate of service demonstrating timely  
13 compliance with the service requirements of this paragraph.

14       **6.**   The court hereby reserves jurisdiction over the matters  
15 specified in § 8.14 of the Plan.
