## Procedures for Appearing on an AT&T Conference Call for the Honorable Stephen L. Johnson

Please ensure your **equipment** is adequate. Also, ensure that you have dedicated, **quiet space** for the call. Do not conduct other conversations while on the call even if you are muted.

- 6. Click on the "**Call me**" button. You will be prompted to add your dial-out number. AT&T will dial out to the number you provided.
- 7. When prompted, select #1 to join the conference
