Please ensure your **equipment** is adequate. Also, ensure that you have dedicated, **quiet space** for the call. Do not conduct other conversations while on the call even if you are muted.

6. Click on the "**Call me**" button. **You will be prompted to add your dial-out number. AT&T will dial out to the number you provided.**
