#### HYBRID AND ZOOM WEBINAR INFORMATION

#### **HYBRID HEARINGS:**

The Courtroom Deputy will email you an invitation prior to the hearing. They will attend in LISTEN-ONLY MODE.
- → When signing into the Zoom Webinar, please enter FIRST AND LAST NAME AND CASE NAME.
- → Please sign into the Zoom Webinar **15 minutes early.**
- → Do not forward or share the Zoom Webinar invitation with anyone.
- → All parties must wear business casual attire.
- → Failure to timely follow these procedures may result in a party or counsel's appearance being waived.

#### **PHONE PROCEDURES:**

- → Parties who dial-in via phone are in LISTEN-ONLY MODE, unless the court instructs otherwise.
- → Attorneys and others intending to appear and be heard on matters on the calendar should <u>not</u> register with CourtCall as they had in the past.
