#### ZOOM PROCEDURES:

The Courtroom Deputy will email you an invitation prior to the hearing. They will attend in LISTEN-ONLY MODE.
- $\rightarrow$  When signing into the Zoom Webinar, please enter **FIRST AND LAST NAME AND CASE NAME**.
- $\rightarrow$  Please sign into the Zoom Webinar **15 minutes early**.
