The Courtroom Deputy will email you an invitation prior to the hearing.
- When signing into the Zoom Meeting, please enter **LINE ITEM NUMBER(s), YOUR FULL NAME, CASE NUMBER(s) ---- #0- FULL NAME XX-XXXX**
- Please sign into the Zoom Meeting **15 minutes** prior.
- Do **not** forward or share the Zoom Meeting invitation with anyone.
- All parties must wear business casual attire.
- Failure to timely follow these procedures may result in a party or counsel's appearance being waived.

PHONE PROCEDURES:
