# Procedures for Appearing on an AT&T Conference Call for the Honorable Stephen L. Johnson

Using information supplied by the courtroom deputy, dial into the AT&T Conference call **15 minutes prior** to the scheduled hearing.

- If signing in by telephone only, please identify yourself to the Courtroom Deputy when you have been connected
- Persons appearing will be authorized by the courtroom deputy to **speak only on the matter they are assigned to.**

Persons requesting **continuances** should notify the courtroom deputy by email in advance of the hearing, otherwise matters will be called in order.

Please ensure your **equipment** is adequate. Also, ensure that you have dedicated, **quiet space** for the call. Do not conduct other conversations while on the call even if you are muted.
