HYBRID AND ZOOM WEBINAR INFORMATION

HYBRID HEARINGS:

The Courtroom Deputy will email you an invitation prior to the hearing. They will attend in LISTEN-ONLY MODE.

- \rightarrow Please sign into the Zoom Webinar **15 minutes early.**
- \rightarrow Do <u>not</u> forward or share the Zoom Webinar invitation with anyone.
- \rightarrow All parties must wear business casual attire.
- \rightarrow Failure to timely follow these procedures may result in a party or counsel's appearance being waived.
