- 1. Select "As Guest"
- 2. Enter (888) 363-4735 in the Dial-in phone number
- 3. Meeting access code: 4426317
- 4. Enter your first and last name and case name
- 5. Check the box "I'm not a robot" and follow the prompt
- 6. Click on the "**Call me**" button. You will be prompted to add your dial-out number. AT&T will dial out to the number you provided.
- 7. When prompted, select #1 to join the conference
