ZOOM PROCEDURES:

- Parties or Counsel who have not filed papers but wish to attend the hearing: Please contact the Courtroom Deputy no less than two (2) days prior to the hearing by email at ruby_bautista@canb.uscourts.gov to request an invitation to the Zoom Meeting. The Courtroom Deputy will email you an invitation prior to the hearing.
- When signing into the Zoom Meeting, please enter **FIRST AND LAST NAME, CASE NUMBER(s) and LINE ITEM Number(s)**. [e.g. Jane Doe, 20-XXXXX, #1]
- Please sign into the Zoom Meeting **15 minutes** prior.
- Do **not** forward or share the Zoom Meeting invitation with anyone.
- All parties must wear business casual attire.
- Failure to timely follow these procedures may result in a party or counsel's appearance being waived.

PHONE PROCEDURES:

- Parties who dial-in via phone may speak and can be heard by the court. Parties must dial-in from touch-tone phone.
- Please call into the Zoom Meeting **15 minutes** prior.
- Do **not** forward or share the Zoom Meeting dial-in information with anyone.
