Motions filed in cases under any chapter of the Bankruptcy Code for relief from the Automatic Stay, to extend the Automatic Stay, or to seek a determination as to whether the Automatic Stay applies; any motion not pertaining to the Automatic Stay filed in a case pending under Ch. 13 of the Bankruptcy code; or motions in involuntary cases.
